INSTRUCTIONS TO THE CANDIDATES

1. *Only candidates who have passed the qualifying degree examination with the minimum marks prescribed are eligible for admission (Refer VSUPGCET - 2020 Instruction Booklet). Others need not attend the counseling.*
2. The following original certificates are to be submitted at the time of counseling:
 - a) VSUPGCET-2020 Rank Card and Hall-Ticket.
 - b) Provisional / Degree certificate of the qualifying examination.
 - c) Marks statements of all the years of qualifying examination.
 - d) Transfer and Conduct certificate (*Original Transfer Certificate is compulsory for admission*).
 - e) Secondary School Certificate (SSC).
 - f) Study certificates from IX class to qualifying examination.
 - g) Aadhar Card.
 - h) Caste certificate in original from *Mee Seva Office* obtained or permanent caste certificate (in the case of SC/ST/BC candidates).
 - i) Valid Income certificate from *Mee Seva Office* (for fee concession).
 - j) Residence certificate of parent for stay in the state of AP in the case of candidates who have studied outside AP or carried out private study.
 - k) Relevant certificates in the case of ECA (NCC/NSS/Games/Sports) candidates.
 - l) Certificate issued by the Medical Board in the case of a PH candidate.
 - m) Discharge certificate and Service certificate of the parent in the case of a Child of Armed Personnel (CAP).
3. The selected candidate has to submit all the original certificates and one set xerox of all certificates. Candidates are advised to keep one more spare copy of Xerox. Because Original & Xerox copy will be retained with University / College.
4. The selected candidate has to pay the Course fee and counseling fee IMMEDIATELY in the bank counter and no extension of time will be given for payment of fee. (Counseling fee an amount of Rs. 400/- (Rs. 200/- for SC/ ST / PH category))
5. A candidate who fails to attend the counseling on the specified date and time will forfeit the right for admission.
6. If it is found that the admission is secured on false grounds or by suppression of facts, his/her admission will be cancelled.
7. **Limited hostel facility available at VSU College for both Girls and Boys.**
8. Jagananna Vidya Deevena(RTF) and Jaganna Vasthi Deevena(MTF) are **not applicable** to those who are admitted in affiliated (Private & Aided) Colleges either Regular (Or) self finance courses as per G.O.Ms.No:77, Social Welfare(EDN) Department, dated:25.12.2020.

Note: In case of changes in Fee Structure as per the directions of the Government, the modified fee will be applicable.

FEE STRUCTURE FOR UNIVERSITY and Govt. COLLEGES

- a) The following Special fee is to be paid at the time of admission those who are admitted into University Constituent Colleges and Government Colleges.
- b) First year and second year tuition fees respectively to be paid to concerned admitted Colleges, as an when the fee amount credited in their respective accounts from the Government. If fails to get tuition fee from the Government, the specified amount should be paid by the student to the concerned college.
