1. The tenders shall be submitted accordingly to the terms and conditions specified in paragraphs 2 to 43 Unless specified otherwise in the tender it shall be construed that the terms & conditions stipulated hereunder have been agreed to.

The firm shall quote the tender price (for ONE LITRE) in tender application (Annexure- I) inclusive of all taxes and transportation amount should be mentioned separately to the VS University Hostels, Kakutur, Nellore. The Vikrama Simhapuri Hostels shall not be liable to pay any tax, any freight etc. which has been expressly stipulated in the tender in the event of acceptance of the tenderer.
4. The firm shall submit the tender in a sealed envelope containing
  - (a) a filled-in tender application form (Annexure-I) with Firm seal, signature, and date & Tender document each page duly signed stamped and page numbering done.
  - (b) a Non-refundable Tender Fee of Rs. 1000/- (Rupees One thousand only)
  - (c) Earnest Money Deposit (EMD) of Rs.5,000/- (Rupees Twenty thousand only) by means of a **Demand Draft Drawn from any nationalized bank in favor of “Registrar, Vikrama Simhapuri University, Nellore” payable at Nellore.**
  - (d) **The Self Attested photocopies of (i) Firm Registration certificate, (ii) Firm PAN Card, (iii) GSTIN Certificate (Wherever applicable) and (iv) Bank Account in the name of the Firm, Income tax returns for the last three years & Tender experience certificates.**
5. The Contractor should have a registered firm in and around SPSR Nellore (Dist). The contract should not be sub-leased to anyone in any manner. Complaints/violations brought to the notice of the Registrar/Chief Warden/Deputy Warden resulting in the cancellation of the rate contract immediately and as a token of firm EMD amount will not be refunded to the firm.
6. The tenderers should submit self-attested copies of the Income Tax returns for the last three years (i.e. for 2022-2023, 2023-2024 & 2024-25).
7. **Tax Deduction (TDS Clause): Applicable TDS under the Income Tax Act or GST Act shall be deducted from each bill as per statutory provisions and deposited to the respective authorities by Vikrama Simhapuri University."**
8. **Bills in triplicate for the items supplied by the firm(s), should be raised for payment. Payment shall be released after deducting TDS as per Income Tax Rules and any other deductions as per Government rules and payment shall be released only after it is ensured that the items/quantity and quantity of items supplied are to the entire satisfaction of this office. If any items are found to be defective, or not of the desired quality etc., the same shall be replaced immediately, for which no extra payment shall be replaced immediately, for which no extra payment shall be made by Vikrama Simhapuri University, Nellore.**

9. **The Tenderer should be a reputed supplier having at least three years dealing experience with the government departments, PSUs, or educational institutions. Certificate in token of proof of experience by way of purchase orders/Agreements, of the concerned department should be enclosed for ready reference.**
10. **The tendering firm/Agency/Company shall be bound by the details furnished by him/her to the Vikrama Simhapuri University, Nellore while submitting the tender or at subsequent stage. Upon selection of the tendering Firm/Agency/Company, if at any stage the document furnished by him /her is found to be false or the quality of the articles or rates are found of poor quality/different specifications, it would be deemed to be a breach of terms of contract, the contract shall be cancelled and performance security shall be stand forfeited.**
11. **The tender should be sent / submitted to the O/o the Registrar, Vikrama Simhapuri University, Kakatur, SPSR Nellore – 524 324 the closing time and date for acceptance of tenders shall be on/before by 05/08/2025. No tender received later the stipulated date & Time or from other modes/ place shall be entertained & shall be declared un –responsive.**
12. **The tenders will be opened on 07/08/2025 in the chamber of Registrar, Vikrama Simhapuri University, Nellore in the presence of such tendering firm/Agency/company or their authorized representatives (only one representative from each company shall be allowed) who wish to be present/witness at the time of opening of bids.**
13. **The Authority reserves the right to reject/cancel any or all the tenders at any time or to relax/amend/withdraw any of the terms and conditions as contained in the Tender Documents without assigning any reason, thereof. Any inquiry after submission of the tender will not be entertained.**
14. **Tenderers shall not approach for refund of EMD till the finalization of the tendering process and award of contract to qualifying Tenderers. If any tenderer approaches for EMD, it will be forfeited at the discretion of the competent authority of VSU, Nellore. EMD shall be refunded to the unsuccessful tenders within 15 days of award of contract to the successful tenders /tenderers.**
15. **The rate for the brand/company/make/specifications, if it is mentioned in the tender to be quoted, tenderer should not quote their own brand or any other quality.**

16. Risk purchase: If the contractor fails to supply the articles within the time stipulated in the letter of acceptance, the undersigned shall be at liberty to purchase the articles from any other sources or from the open market or get the rest of the contract completed by any other person or firm and the difference of price, if any shall be deducted from the earnest money deposit OR claim the difference in price on higher side from the Contractor/deduct from the bills on hand and the V.S. University college hostels will adopt any other method to realize the same.
17. In the event that the Contractor fails or refuses to supply the items for any reason after the agreement, at any stage before the completion of the contract period, the following penalties shall apply:
  - \* The Earnest Money Deposit (EMD) shall be forfeited.
  - \* The contract shall be terminated, and the next lowest bidder shall be selected to complete the contract.
18. Free items/gift/scheme extended by manufacturer/company/supplier/firm is also extended to VSU Hostels without any extra amount.
19. **The price finalized by the central purchase committee is final/remains the same and requests for rate enhancement during the contract period will not be entertained.**
20. The undersigned does not bind himself to accept the lowest tender and reserve the right to accept the tender in whole or in part i.e, with respect to articles mentioned in the attached statement and or in respect of any one or more than one articles specified in the attached statement as he may decide.
21. On acceptance of the tender it will become a contract and shall be a contract and shall be bound by the terms & conditions of the tender. The contract shall be executed in Document paper (Bond paper/E Stamp Paper) worth Rs.100/-, the cost of which will be borne by the bidder only along with the supply of items the contractor has to furnish the bill/invoice (in prescribed format which will be containing the GST registration number) for necessary payment from the funds of Vikrama Simhapuri University College Hostels, Kakatur, Nellore.
22. In case of any dispute between Vikrama Simhapuri University Hostels and the firm, the decision of the Vikrama Simhapuri University authorities is final and binding on both parties.
23. **Vikrama Simhapuri University authorities reserve the right to extend/cancel the Contract partially/fully at any time by giving 30 days written notice for justifiable reasons. Immediate termination will be enforced for serious violations or fraud.**
24. The liberty to carry out negotiations or accept the lowest tender as such is vested with Hostel Committee and will be exercised after opening and compiling the same and L-



1 bidder shall be decided on the basis of lowest rate quoted by any of the bidder and the bidder, who have quoted of in L-1 rate shall be given opportunity by the competent authority of VSU, Hostels Nellore and ask him in writing to match L-1 price of other items quoted by him in comparison of other bidders, where his quote has not found L-1.

25. In case of the supply of damaged Milk & Curd packets or spoiled Milk & Curd on any particular day, the firm shall replace them with good quality immediately at free of cost.
26. There should not be any overwriting or corrections in the tender. If figure is to be amended, it should be neatly scored out and the revised figure write above and the same to be attested with full signature and seal of the firm with date. In the absence of attested signature the tender is liable to be rejected.
27. Prior to acceptance of the tender, the undersigned reserves the right to call for sample or demonstration and contractor shall be liable to supply the sample/specimen or give the demonstration at free of cost.
28. In the event of acceptance of the tender and placing the order for the purchase of the articles ordered for would be subject to an inspection by the undersigned or his representative and are liable to be rejected if the articles supplied are not according to approved sample/specimens or do not confirm to the specifications prescribed.
29. **Party/bidder/person, bidding in any tender/quotation HAS NO right to include/incorporate or insist any terms OR conditions or demands for supply/service of any items. And the decision of the undersigned on any matter, in the best interest of the VSU Hostels, shall be final and binding. 30. **Delivery Timing: The supplier must ensure delivery of materials before [e.g., 7:00 AM] each day, unless otherwise specified. Late deliveries will be subject to inspection and potential rejection.**
31. **Penalty Clause for any delay: A daily penalty of [e.g., 0.5% of order value per day], subject to a maximum of [10%], shall be levied for any delay in supply beyond the specified timeline without valid justification.**
32. Bidder/party shall NOT strike out any of the above terms & conditions and if done so, his/her/their tender/quotation will be rejected summarily.
33. The monthly bill shall be submitted to Chief Warden, VS University Hostels on the last day of the month and payment will be made to the firm bank account after successful bill processing within 15 working days.

34. **The bidder is advised to be conversant with the terms and conditions as stated above before accepting the Contract.**
35. The bills raised by the selected tendering Firm/Agency/Company should have all tax registration numbers printed on bill. The bill shall be signed by the authorized signatory of the firm across a revenue stamp.
36.
