Step 3	Appointment of Facts Finding Committee for Affiliations(FFCA) to visit Colleges for Verification Facilities and Documents
Step 4	FFCA submits the Inspection Report in Online during the Inspection Process
Step 5	Scrutiny Committee to review Inspection Reports submitted by FFCAs and prepares recommendations to place before Executive Council for approval
Step 6	Generation and Issuance of Affiliation Orders after Executive Council approval
Step 7	Receiving any Grievances with regard to Affiliation
